MLA Format (332 and 23) In-Text Citations (332): MLA in-text citations include the title of the sacred work, the book, the chapter, and the verse Abbreviate the name of the book and use a period to separate the chapter and verse The title of the sacred work must be included in your first citation but is left out of subsequent citations
